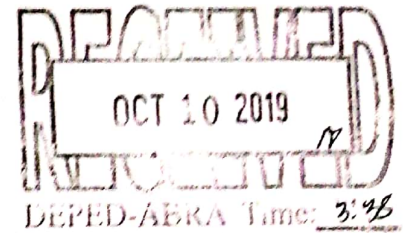

**2019 ABRA PROVINCIAL ATHLETIC MEET**

1. The 2019 Provincial Athletic Meet will be conducted on November 17 - 22, 2019. Arrival will be in the morning of November 17, 2019 and a solidarity Meeting at 1:00 o'clock in the afternoon at the gymnasium of Abra Sports Center.
2. This special event aims to:
  - a) Discover, identify and develop potential athletes to represent the province to the 2020 CARAA Meet.
  - b) Promote camaraderie between and among athletes, teachers and administrators in the province through sports.
3. Participation to this event shall come from the Elementary and Secondary Division (including Senior High), private and public, broken down as follows:

**ELEMENTARY DIVISION**

- a. ZONE 1 – Bangued East and West Districts
- b. ZONE 2 – San Juan and Tineg and Districts
- c. ZONE 3 – Pidigan, Langiden, San Quintin and Peñarubia Districts
- d. ZONE 4 – Bucay and Manabo Districts
- e. ZONE 5 – La Paz, Danglas and Lagayan Districts
- f. ZONE 6 – Sallapadan, Bucloc, Daguoman and Boliney Districts
- g. ZONE 7 – Luba and Tubo Districts
- h. ZONE 8 – Pilar, San Isidro and Villaviciosa Districts
- i. ZONE 9 – Lagangilang, Baay-Licuan, Lacub and Malibcong Districts
- j. ZONE 10 – Diocesan Schools (elementary)
- k. Zone 11 – Dolores and Tayum (DOTA)

4. Each Zone and Unit shall bring their own banner and drum and lyre corps for the opening parade and program.
  5. All Zones and Units are encouraged to field their teams in all sports discipline in order to provide optimum exposure of athletes in the forthcoming Abra Provincial Athletic Meet.
  6. Pertinent documents of athletes, coaches, Assistant coaches and chaperons must be presented and submitted on **November 4 - 8, 2019** to the Division Screening and Accreditation Committee. The required documents for submission are as follow:

      - a. Certificate of training, relevant coaching experience
      - b. Appointment (Public) Contract of Service (Private)
      - c. Omnibus Affidavit
      - d. Medical Certificate
    - B. **For Chaperon**
      - a. Certificate of Commitment
      - b. Medical Certificate
    - C. **For Athletes**
      - a. AR (Athletes Record)
      - b. Original Copy of PSA/NSO
      - c. SF 10/ Form – 137
      - d. Certificate of Attendance (for Palarong Pambansa Only)
      - e. Parental Consent/Affidavit/Sworn Statement of Actual Care of Custody
      - f. Medical Certificate
      - g. Dental Certificate

A half day meeting will be conducted on November 14, 2019 at 8:00 AM at the SDO-Abra conference hall to be attended by the delegation head of each zone and unit including the members of Division Screening and Accreditation Committee and the tournament managers of the Different sports discipline. (list of tournament managers will be released through another Division Memorandum)
9. All sports coordinators and officiating officials within the zone and unit should disseminate all rules, policies and guidelines, relative to the conduct of the events to be competed to minimize all unwanted circumstances during the meet.
10. The officiating officials to the 2019 Provincial Athletic Meet shall be those who are duly accredited by national, Regional, and Division. (list of officiating officials will be released through another Division Memorandum)
11. The technical management and game administration shall be under the direct supervision of the Schools Division Superintendent, Gloria B. Buya-ao, with the assistance of Christopher C. Benigno, OIC-Assistant Schools Division Superintendent, Lemuel B. Dickson, Ed. D, SGOD Chief, Ronilo P. Garcia, EPS-SGOD, and the different tournament managers of the different sports disciplines.
12. No Closing program will be conducted, the results of the 2019 Abra Provincial Athletic Meet be declared and awarded during the Management Committee Meeting. No medals and trophies to be Awarded instead certificates will be given.
13. It is also requested that the nurse of each unit or zone shall be included in the delegation and they are expected to actively look after the health condition of athletes during the duration of the meet.
14. School officials and athletes are reminded that any misrepresentation or dishonesty committed will be dealt with accordingly without prejudice of filing an appropriate administrative charge.
15. Officiating Officials shall have their lay outing of their respective playing venues/courts on November 14 and 15, 2019.
16. A half-day Solidarity Meeting will be conducted on November 17, 2018 at 1:00 PM at Bangued West Central School gymnasium, to be attended by the following:
