- Leaner must be endorsed by the School Head with supporting documents/s (Accomplishment Report)
 in the Preventive Education Campaign.
- The selection of the outstanding candidate by school will be submitted to the Division Office starting February 24 until February 28, 2020. Entries will be selected during the Initial Screening by the Division Office on March 3, 2020.
