

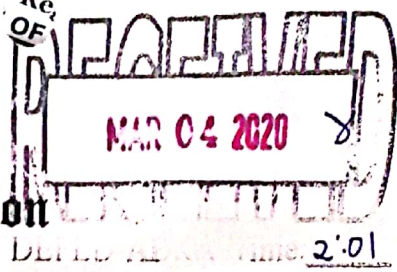

PARTNERSHIP WITH PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA) IN PREVENTIVE DRUG EDUCATION

To: Chief Education Supervisors, SGOD and CID
All Public and Private Elementary and Secondary School Heads
All Others Concerned

1. In support of the National Drug Education Program's (NDEP) implementation in compliance with Republic Act No. 9165, or the Comprehensive Dangerous Drugs Act of 2002 and DepEd Order No. 12, s. 2009, this office hereby express its desire to work collaboratively with the Philippine Drug Enforcement Agency (PDEA) and reminds the school heads to supervise, give full support and intensify the Preventive Drug Education Program in schools.
2. In coordination with the School Health Section, PDEA will be conducting drug-awareness lectures on illegal drugs to all public and private schools in the Schools Division of Abra and School Heads shall ensure the following:
 - a) Activities are well-coordinated with PDEA.
 - b) Lectures should provide age-appropriate explanations and offer age-appropriate teaching materials.
 - c) Strictly no collection of fees is allowed.
 - d) Completion report/documentation should be submitted to SDO Records Section - Attention: School Health Section in a one (1) page narrative and picture form, one (1) week after the conduct of the activity.
 - e) Activities shall be spearheaded by the SSG/BKD/NDEP Coordinators/Advisers.
 - f) Random drug testing for employees, elementary and secondary students is not included within the scope of this memorandum.
 - g) Institute measures to increase engaged Time-On-Task as per DepEd Order No. 9, s. 2005.
