

### Division-Webinar and Home-based Workshop on the Development of Modules (EPP,TLE,TVE) for 4-10 Learners

- 1. The Learning Resource Management Section shall provide technical assistant in accordance with the technical quality assurance, Design and Development Standards of the Bureau of Learning Resources.
- Each Participant, Training Facilitator/ Speaker will be downloaded with an eload worth 150.00 x three days which will be used for the data e-net/i-net connectivity.
