Invitation to Bid for the CY 2020 Basic Educational Facilities Fund – Electrification on Un-Energized Schools and Modernization of Electrical Systems On-Grid Schools

The Department of Education, Schools Division of ABRA through the Repair of Classrooms under CY 2020 Basic Educational Facilities Fund (BEFF) – Electrification of Un-Energized Schools and Modernization of Electrical Systems On-Grid Schools intends to apply the sum of Twenty-Seven Million One Hundred Ninety-One Thousand Six Hundred Twenty-Seven pesos (*PhP27,191,627.00*) being the Approved Budget for the Contract (ABC) to payments under the contract for the Electrification of Un-Energized Schools and Modernization of Electrical Systems On-Grid Schools under the CY 2020 Basic Educational Facilities Fund (BEFF). Bids received that exceed the ABC shall be rejected at bid opening.

The Department of Education, Schools Division of Abra now invites bids for Electrification of Un-Energized Schools and Modernization of Electrical Systems On-Grid Schools under the CY 2020 Basic Educational Facilities Fund (BEFF). Completion of the Works is required for (see summary of projects). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidders are required to be a licensed contractor of the Philippine Contractors Accreditation Board (PCAB) with Registration Particulars SP-EE (Electrical Work) minimum category A due to the nature of the program and project. Prospective contractors/bidders with PCAB license classification for General Engineering and/or General Building are not eligible to

participate, and are advised to secure the appropriate PCAB Registration Particulars on Electrical Works prior to participating in any bidding to be conducted by the Department and to be eligible to undertake the project (OUA Memo 10-0120-0599, Memorandum, January 23, 2020 – Required PCAB License of Bidders for DepEd Electrification and Solar Projects).

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Department of Education, Schools Division of Abra, Actividad-Economia St., Zone 2, Bangued, Abra and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM (Monday-Friday).

A complete set of Bidding Documents may be acquired by interested bidders on **November 27, 2020** at the Department of Education, Schools Division of Abra, Bids and Awards Committee (BAC) Secretariat, Actividad-Economia St., Zone 2, Bangued, Abra and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten thousand pesos (Php10,000.00)** per lot.

The Department of Education will hold a **Pre-Bid Conference on December 4, 2020, 9:00 AM** at DepEd, Schools Division of Abra Conference Hall which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **December 16, 8:30 AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 16, 2020, 9:00 AM at *DepEd SDO-Abra Conference Hall, Bangued, Abra*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Department of Education, Cordillera Administrative Region, SDO-Abra reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
