**CORRIGENDUM OF THE DIVISION MEMORANDUM NO. 273, s. 2020**  
 (LEADERSHIP CAPABILITY BUILDING OF SPG AND SSG TEACHER-ADVISERS AND OFFICERS)

1. In observance of the Inter-Agency Task Force (IATF) Resolution No. 79, s. 2020 dated October 15, 2020, under common paragraph (3) of Sections [2] and [3] on the Guidelines for Areas Placed Under Enhanced Community Quarantine and Modified Enhanced Community is amended, to wit: "Any person below fifteen (15) years old, those who are over sixty-five years (65) of age, those with immunodeficiency, comorbidity, or other health risks, and pregnant women, including any person who resides with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under circumstances for obtaining essential goods and services, or for work in industries and offices or such other activities permitted in this Section."

2. District-Wide SPG Teacher-Advisers and SSG Teacher-Advisers of Secondary Schools are the only ones who will participate on the said training.

3. Training Team and Resource Speakers from DepEd-Schools Division Office of Abra will also be given a one (1) day Service Credit-COC for their attendance on November 28, 2020.
