CAREER GUIDANCE ORIENTATION AND DIVISION TRAINING ON CYBER-SAFETY IN SCHOOLS

To: CHIEF, School Governance and Operations Division

- 1. In view of the full implementation of SHS through the DepEd Order No. 41, s. 2015, shall ensure that all Grade 10 completers and those outside the formal education system are enrolled in Senior High School. DepEd, through the SHS Career Guidance Program, shall assist SHS entrants in building innovative decisions concerning a track suitable to their capabilities and interests that coordinates the existing resources and needs of the public. It also intends to institute guidelines for the conduct of SHS Career Guidance Program in preparation for the full implementation of the Senior High School and to guide Grade 10 students in making informed decisions in their choice of SHS track and to promote awareness in the importance of choosing a track suitable to their skills and interests, and in pursuant to DepED Memorandum No. 94, s. 2016 on Promotion of Online Child Protection and Prevention of Cyberbullying and an advocacy of protection of all children, regardless of sex and gender from online abuse, violence, exploitation, discrimination and bullying, an orientation will be conducted on December 17-19, 2020 at Rylanyan Place View Point Hotel, Casamata Hill, Banqued, Abra.
- 2. Participants are Guidance Counselors and Designates of both Elementary and Secondary Schools.
- 3. Relative to the training, Guidance Counselors and Designates are given a one (1) day Service Credit-COC for their attendance on December 19, 2020 which falls on a Saturday.
- 4. Travel expenses and per diem of the participants will be charged to School MOOE/Local Funds, meals snacks and other expenses will be charged to the Division HRTD Funds, downloadable funds from Regional Office-CAR, subject to usual accounting and auditing rules.
- 5. For dissemination, guidance and strict compliance to this memorandum is desired.
