Frequently Ask Questions under DepEd Order No. 50 s. 2016 and DepEd Order No. 07 s. 2016.

Question	Answer
• What is the best proof of being an IP?	Identified list of IP schools and a certificate as an IP from the designated IPMR to verify the identity of the applicant.
• Who is responsible in the shortlisting of applicants?	School level in the School Selection Committee. At any level or process when there are corrections, the applicant will be informed of changes.
• When is the deadline of submission of application documents?	The deadline of submission of application documents is on February 26, 2021 and that is to be strictly implemented. Any new document that is submitted after the said deadline will not be accepted.
• Can NBI Clearance be excluded as a requirement?	Yes. With the pandemic, this will not be required yet.
• How is LGU, LSA and Volunteer Teaching counted as an experience? (DO No. 50 s. 2016)	The applicants will present a document as proof of experience in teaching IPEd in an IP school. On LSA, the school head will issue a certification and attach a photocopy of the contract. They will only count the months rendered as LSA, LGU or Volunteer until March 2021. If the applicant started to work as LGU, LSA and Volunteer before October 2020 they have to see to it that the task done is teaching related.
• Is there an additional point for applicants who can demonstrate teaching using their mother tongue?	An applicant from Kinder to Grade 3 whose demonstration teaching is in the mother tongue and conducted a contextualized demonstration, five (5) points will be added to his/her score. The possible score highest score will be twenty-five (25) points under DepEd Order No. 50 s. 2016 and twenty (20) points under DepEd Order No. 07 s. 2015.
• What is the validity of EPT? • Can an applicant take the EPT twice or more?	• The EPT Examination result is only valid for 2 years. • Applicants can take the EPT Examination twice or more within two (2) years. The higher rating will be considered in the RQA.
• There are unsigned documents submitted, will these be considered?	No, the Schools Selection Committee must ensure that all the documents were signed by the applicant.
• If an applicant does not have the general weighted average (GWA), can he/she be considered?	Yes. The SSC will compute the general weighted average of the applicant.
• If the Voter's ID is not available, what is the replacement?	When the applicant does not have voter's ID they may secure voter's certification from COMELEC or Barangay certification from the barangay captain.
• Can an applicant apply for Kinder, SpEd and ALS?	Yes. The RQA of SpEd and Kinder is separate. If an applicant wishes to apply for kinder and elementary, then he/she will perform demonstration separately.
• How is the scoring on Specialized Training?	Certificate of Specialized Training is equivalent to five (5) points and NCII is ten (10) points. If an applicant has undergone the skills demonstration but does not have the NC II as a proof, then the applicant gets five (5) points only.
