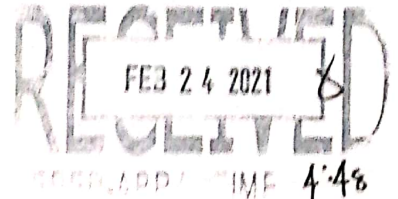

**UPDATING OF CPP SCHOOL PROFILE AND REPORTS ON CHILD ABUSE AND BULLYING IN THE LEGAL SERVICES INFORMATION SYSTEM 3.0 (LSIS 3.0), AND REPORTING OF SCHOOLS THAT ADOPTED, MODIFIED, CONTEXTUALIZED OR IMPROVED THE STUDENT DISCIPLINE MANUAL**

1. The Department of Education – Cordillera Administrative Region introduced the first version of the Legal Services Information System (LSIS 1.0) in 2016. The latest version or LSIS 3.0 was conceptualized to automate reporting, updating and consolidation of child protection data, which is one of the three legal services of DepEd-CAR. It is processed through an online internet based information system so that data can be seen real time in the School level up to the Regional Office.
- 2) The Schools Division Office of Abra have conducted series of activities and issued memoranda pertaining to Child Protection Policy of the Department of Education. On April 23, 2020, an online consultation on the Gender Responsive and Non-Discriminatory Student Discipline Manual was facilitated to present the draft of the said manual, and gather recommendations, suggestions, ideas, proposals on the provisions thereof. While on August 18, 2020, the Division Office issued a memorandum requiring all schools to generate all child protection data using the CPP Data Tool from S.Y. 2016-2017 until S.Y. 2019-2020. Thereafter, the administrators, principals, and representatives from the private schools were given an update as to the Regional Memorandum No. 173, series of 2020 or the Regional Policy on Student Discipline Manual or the GRaNdSDiSM. On November 25, 2020, the Division Office, through its Information Technology Officer, has sent verification e-mail to each of the public school's official e-mail address, for the creation of school account in the LSIS 3.0. Lastly, on January
