REQUEST FOR SUBMISSION OF SCHOOL-BASED FEEDING PROGRAM (SBFP) PREPARATORY REPORTS AND BMI OF ALL INCOMING GRADE 1 FOR SCHOOL YEAR 2021-2022

1. Pursuant to the Operational Guidelines on the Implementation of School-Based Feeding Program (SBFP), the Schools Division of Abra through the School Governance Operations Division (SGOD)-School Health Section (SHS) continues to implement the School-Based Feeding Program (SBFP) for School Year 2021-2022 to address undernourished and all Kindergarten learners in public elementary schools.
2. The Implementation of the SBFP shall be modified, putting utmost importance to the welfare safety and health of learners and personnel involved, while also ensuring the attainment of the program objectives. The program shall be implemented in line with the adjusted Basic Education Learning Continuity Operations Plan (BE-LCOP) in consideration of the changes brought about by the COVID-19 pandemic.
3. The SBFP covers all Severely Wasted (SW) and Wasted (W) learners based on the beneficiaries of SY 2019-2020 and all incoming Kindergarten for SY 2021-2022. The program aims to improve the children's health and nutrition values and behavior.
4. All schools are advised to conduct early nutritional assessment of all incoming Grade 1 learners for SY 2021-2022 and submit reports on the nutritional status of all SBFP recipient schools using the BMI Template to Schools Division Office through the School Governance Operations Division (SGOD)-School Health Section.
5. In line with this, height and weight for all incoming Grade 1 learners shall be taken inside the school by school nurses and the homeroom teacher-adviser starting August 9, 2021 in scheduled basis and strict compliance of the DepEd Order No. 14, s. 2020, Guidelines on the Required Health Standards in Basic Education Offices and Schools, all SBFP actual beneficiaries must be dewormed before the start of the feeding.
6. All SBFP Reports must be accomplished and submitted at the Schools Division Office through the School Governance Operations Division (SGOD)-School Health Section before/during and after the feeding program. The deadline of submission of the preparatory reports in hard & soft copies using the attached forms is on September 13, 2021.


