**CONDUCT OF 2020-2021 COMPLETERS PORTFOLIO ASSESSMENT AND
COMPLETION ACTIVITIES**

1. Joint Memorandum DM -OUCI- 2021-316 Issued August 12,2021 stated that as per Bureau of Education Assessment (BEA), the administration of Accreditation and Equivalency (A&E) Test for School Year (SY) 2020-2021 Alternative Learning System (ALS) Program Completers will not be possible due to the restrictions imposed by the government in view of the Covid-19 pandemic.
2. In lieu of the administration of the aforesaid test, the Department of Education (DepED), through the Curriculum and Instruction strand and the ALS Task Force (ATF), announces that the result of the presentation portfolio assessment for ALS Elementary and Junior School Program Completers of SY 2020-2021 and previous years in the Learner Information System (LIS) shall be used as basis for the issuance of an Elementary Diploma or Junior High School Level Certificate of Program Completion.
3. School heads of public elementary and junior high schools shall accept ALS program completers who passed the final assessment to temporary enroll in Grades 7 and 11 while waiting for the result of the inter-district revalida. *(For more details please refer to Joint Memorandum DM -OUCI- 2021-316 Issued August 12,2021.)*
4. Due to the above premise, Curriculum Implementation Division ALS Section (CID-ALS) will conduct series of inter-district validation of portfolio assessment and completion activities at the ALS Community Learning Centers (CLCs) on August 16, 2021 to October 8,2021. The activity will culminate with the conduct of Virtual Graduation Ceremony for ALS EL and Moving Up Ceremony for ALS JHS Completers.




