- With reference to the DepEd Order 36 s. 2019 supplemented by DepEd Order No 22 s. 2020 on the Implementation of School-Based Feeding Program (SBFP)- Milk Component the Schools Division of Abra through the School Governance Operation Division-School Health and Nutrition Section will facilitate the delivery and distribution of Pasteurized/Fresh and Sterilized Milk to the 231 School Recipients for SY 2020-2021.
- 2. The Milk Feeding Component will support the implementation of School-Based Feeding Program (SBFP)-Nutritious Food Products (NFP) regular component. All the 231 SBFP Recipient Schools for School Year 2020-2021 with 8,489 Elementary Learner Beneficiaries (ELB) will received 1sachet (180-200ml) per beneficiary per day for 22 feeding days. Schedule of delivery and distribution of Sterilized Milk will be on October 6-7, 2021 and Pasteurized/Fresh will be on October 11, 2021 to November 18, 2021 at Bangued West Central School Gymnasium.
