WINS MONITORING PROGRAM FOR SY 2021-2022

I. To set specific parameters and standards essential to every learner's right to access WinS and learning centers nationwide, the Department of Education issued the DepEd Order No. 10, s. 2016 titled *Policy and Guidelines for the Comprehensive Water, Sanitation and Hygiene in Schools Program*.

II. In line with this the Office of the Undersecretary for administration directs School Division Superintendents to ensure that all schools report and update their WinS Status yearly with the use of the Three Star Approach (TSA). The WinS Reporting and Monitoring Forms can be accessed through <https://deped-wins.sysdb.site/Login>.



III. Kindly refer to this reminders

- a) For Schools that are part of the pilot implementation of Face-to-face classes.
 - i. Fill up the WinS Monitoring Tool using the **current School Year's data** for all the indicators.
- b) For Schools that remain under Remote/ Alternative Learning Modalities:
 - i. Use the data for inapplicable indicators from SY 2019-2020 or refer to OUA Memo 00-0521-0145 dated 06 may 2021 for the guidelines on filling out the WinS Monitoring Tool
 - ii. For the indicator on daily group hand washing activity, use the data from SY 2019-2020 or indicate that this is met through the strict implementation of hand washing for everyone entering school premises. Answer question no. 32 of the WinS Monitoring Tool with 5 times a week and indicate involvement of teachers and students assigned to support hand washing at the school entrance.
- c) For the username and Password
 - i. The default username for each school is "sch" followed by the school ID (i.e. sch123456) and the default password is "p".

IV. All schools are advised to refer to the WinS booklets on Water, Sanitation, hygien and Deworming for additional details on compliance with indicators. These maetrials are available at the DepEd WinS official Webpage at <https://wins.deped.gov.ph/category/wins-resources>.
