**REITERATION OF UPDATING THE CPP SCHOOL PROFILE IN THE DEPED-CAR
LEGAL SERVICES INFORMATION SYSTEM (LSIS) 3.0 AND MANDATORY
ATTENDANCE FOR SCHOOLS REPRESENTATIVE FOR A WORKSHOP TO
UPDATE THEIR CORRESPONDING CPP SCHOOL PROFILE**

1. Since 2016 the Legal Services and Information System (LSIS) has been adopted by DepEd – CAR; and all elementary and secondary schools within the Region was mandated to use the said system in accomplishing CPP documentary requirements pursuant to **DepEd Order No. 40 s. 2012 (DO no. 40)**, otherwise known as the DepEd Child Protection Policy.
2. In accordance to the Regional Memorandum No. 066 series 2021 – First Quarter Interface – with SDO and RO Personnel Providing Legal Services, **all private and public schools are mandated to completely update the school's CPP School Profile, and Reports on Bullying and Child Abuse** beginning school year 2016-2017 up to the present school year.
3. In the Second Quarter Interface with SDO Counterpart and Convergence with Strategies with Stakeholders of Host SDO under Regional Memorandum No. 277 s. 2022, it sets the goal of a 100% updates for CPP School Profile, and Reports on Bullying and Child Abuse for each eight (8) Schools Division of the Cordillera. **The deadline for updating is on July 8, 2022.**
4. As per the record on the LSIS 3.0, only 65 public and private schools in SDO-Abra have updated their CPP Schools Profile.
5. To ensure compliance, all schools are mandated to attend the **workshop at the Division Office of Abra** to update their CPP School Profile, with the assistance of the Legal Services Unit, Youth Formation Focal Person and the ITO.
6. The schedules for schools per district are to be strictly followed. To be announced on July 4, 2022.
