FIRST AID PROVISION AND WELLNESS**

1. To continuously ensure the effective and efficient provision of Legal Services to all women and men stakeholders, female and male learners in the region, the Office of the Regional Director through the Legal Unit in Coordination with the Schools Division of Abra Legal Section will be conducting the Fourth Quarter Interface with SDO Counterparts.
