SCHOOL REPRODUCTION OF INDIVIDUAL HEALTH EXAMINATION CARDS TO ALL LEARNERS AND TEACHING AND NON-TEACHING PERSONNEL FOR ANNUAL HEALTH PROFILING

To: **Assistant Schools Division Superintendent**
Chief, Curriculum Implementation Division (CID)
Chief, School Governance and Operations Division (SGOD)

Public Elementary and Secondary School Heads
All Others Concerned

1. Pursuant to DepEd Order No. 28, s. 2018, titled *Policy and Guidelines On Oplan Kalusugan sa Department of Education*, schools are directed to reproduce Individual Health Examination Cards for the health assessment of learners, teaching and non-teaching personnel.
2. The Individual Health Examination Cards may be downloaded through this link: <https://bit.ly/IHC2023>
3. The health cards shall be properly accomplished and signed by school health personnel in the conduct of medical and dental examination and treatment.
4. All collecting, storing, processing, reporting, and other uses of data from learners and personnel shall be conducted in accordance with the provisions of the Data Privacy Act and the Data Privacy Policies of DepEd. The health cards shall be stored at the school clinic for safekeeping by the designated clinic teacher.
5. Expenses incurred in the reproduction of the health cards may be charged to school MOOE following usual accounting rules and regulations and procedures.
6. The reproduction of health cards and the recording and reporting of learner's health data generated for the BEIS and for the OKD shall be monitored by the Division TWG and shall provide necessary technical assistance to schools. Transportation, per diem and other incidental expenses shall be charged against the OKD Support Funds/SBFP Support Funds/Division MOOE subject to usual accounting and auditing procedures.
7. For immediate dissemination and compliance.
