SCHOOL-BASED ONE HEALTH WEEK FOR 2022-2023

To: **Assistant Schools Division Superintendent**

1. In reference to DepEd OUGFO Memo 2022-03-1037 titled **Guidance to Regional/Division School Health and Nutrition Personnel re: Conduct of the One Health Week for SY 2022-2023** and pursuant to DepEd Order No. 28 s. 2018 titled **Policy and Guidelines on Oplan Kalusugan sa Department of Education**, all public elementary and secondary schools are directed to conduct their respective One Health Week celebrations on **January 30 to February 3, 2023**.
2. The theme for the celebration is **"Pinalakas na Kalusugan sa DepEd, Pinatatag na Healthy Learning Institutions"**, emphasizing the implementation of Oplan Kalusugan sa DepEd flagship programs and to ensure that DepEd schools are **"health learning institutions, for the health, safety, and well-being of learners."**
3. Each day of the One Health Week will showcase sets of activities that shall focus on a specific OK sa DepEd flagship program. **It is emphasized that the Engaged Time-on-Task Policy of DepEd should be observed as stipulated in DepEd Order No. 9, s. 2005 and DepEd Order No. 34, s. 2022.**
4. Schools that first conducted One Health Week last November 2-4, 2022 and November 7-11, 2022 shall no longer conduct the said activities on January 30 to February 3, 2022. Funding for the effective and sustainable implementation of One Health Week and OKD shall be charged from the school MOOE subject to the usual accounting and auditing policies, procedures and standards.
5. The Division Kick-off will be held on January 30, 2023 at **Luzong Elementary School and Luba Central School**. Relevant to this, all Division-based School Health Personnel are enjoined to attend the Kick-off Ceremony.
7. The One Health Week shall be monitored by the SDO-Based School Health Personnel and shall provide necessary technical assistance to schools. Transportation, per diem and other incidental expenses shall be charged against the OKD Support
