

Division Memorandum No.210 s. 2023

TO: Chief Education Supervisor CID Public Schools Division Supervisor School Heads All others concerned

- 1. The Department of Education, Schools Division of Abra supports and acknowledge the importance of road safety and traffic rules. Thus, this Office recognizes the need to observe these rules and regulations in order to guarantee the safety of learners, and employees inside and around the vicinity of the school area, as well as the motorist who are travelling using the national, provincial or municipal road.
- 2. As per the Resolution dated May 08, 2023, furnished by the Office of the Sanguniang Panlalawigan during the 28th Regular Session of the 11th Sanguniang Panlalawigan of Abra, which was signed, carried unanimously by all the members present during the said session, attested by Vice Governor, Honorable Maria Jocelyn V. Bernos and later approved by the Provincial Governor, Honorable Dominic B. Valera. The Resolution No. 97 series of 2023 entitled "A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION, DIVISION OF ABRA AND THE BARANGAY WHICH HAS JURISDICTION OVER THE SCHOOLS ALONG NATIONAL, PROVINCIAL OR MUNICIPAL ROADS THAT INSTALL ROAD SIGNS TO REMOVE OR CLEAR THE SAID SIGNAGES AS SOON AS THE PUPILS/STUDENTS HAVE ENTERED THEIR RESPECTIVE CLASSROOMS BUT NOT LATER THAN 8:00 AM AND SHALL REINSTALL THEM BACK DURING DISMISSAL TIME BUT NOT EARLIER THAN 4:00 PM" is hereby acknowledged and recognized.
- 3. By virtue of the aforementioned Resolution, the following shall be observed:
- a) That the road signages be authorized to be installed in school zones along national, provincial, or municipal roads during school days, and during all occasions that require student's/ pupil's attendance in school, but do not fall under school days, and remain there as such until all students/pupils have entered the school campus, premises or their respective classrooms.

b) That the road signs shall be removed or cleared from the roads as soon as all students/pupils have entered the school campus, premises, or their respective classrooms but not later than 8:00 AM and the same shall be re-installed during dismissal time not earlier than 4:00 PM.

- c) The installation of road signages on occasions that require students'/pupil's attendance in school but that do not fall under school days shall be on a case-to-case basis or as the need arises.

Resolution No. 97 Series of 2023

A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION, DIVISION OF ABRA AND THE BARANGAY WHICH HAS JURISDICTION OVER THE SCHOOLS ALONG NATIONAL, PROVINCIAL OR MUNICIPAL ROADS THAT INSTALL ROAD SIGNS TO REMOVE OR CLEAR THE SAID SIGNAGES AS SOON AS THE PUPILS/STUDENTS HAVE ENTERED THEIR RESPECTIVE CLASSROOMS BUT NOT LATER THAN 8:00 AM AND SHALL REINSTALL THEM BACK DURING DISMISSAL TIME BUT NOT EARLIER THAN 4:00 PM.

WHEREAS, the Provincial Government of Abra fully supports the initiative of the DOTr, the Department of Education, Department of the Interior and Local Government (DILG) and, the Land Transportation Office (LTO) to ensure that important road safety laws are observed around school zones, to keep children safe on roads and the installation of road signs along national, provincial or municipal roads adjacent to school premises;



WHEREAS, the Department of the Interior and Local Government (DILG) had issued Memorandum No. 2022-85, dated June 20, 2022, mandating the implementation of road clearing in the new normal;

WHEREAS, pursuant to the aforementioned Memorandum, the road clearing shall refer to the act of removing or causing to remove obstructions or encroachments to the roads;

WHEREAS, to reconcile the two initiatives of the government in the Province of Abra, it is hereby resolved that:

- The road signages be authorized to be installed in school zones along national, provincial
 or municipal roads during school days, and during all occasions that require
 students'/pupils' attendance in school, but that does not fall under school days, and remain
 there as such until all the students/pupils shall have entered the school campus, premises
 or their respective classrooms.
- However, the road signs shall be removed or cleared from the roads as soon as all the students/pupils shall have entered the school campus, premises or their respective classrooms but not later than 8:00 AM and the same shall be re-installed during dismissal time but not earlier than 4:00 PM.
- The installation of the road signages on occasions that require students'/pupils' attendance in school but that does not fall under school days shall be on a case-to-case basis or as the need arises;

NOW, THEREFORE, premises considered, and upon motion of Hon. Edwin B. Crisologo, Sr., Chairman, Committee on Local Governments, be it

RESOLVED, as it hereby **RESOLVED**, to request the Department of Education, Division of Abra and the barangay which has jurisdiction over schools along National, Provincial or Municipal roads that install road signs to remove or clear the said signages as soon as the pupils/students have entered their respective classrooms but not later than 8:00 AM and shall reinstall them back during dismissal time but not earlier than 4:00 PM.

RESOLVED, FINALLY, that copies of this resolution be furnished to Department of Education, Division of Abra, DILG-Abra Field Office, Abra PPO, and all the 27 Municipalities of Abra and to all offices concerned for their information and appropriate action.
