1. Republic Act No. 8371 of 1987, otherwise known as The Indigenous Peoples Rights Act (IPRA) which was emanated from the constitutional provision, the recognition and protection of the rights of the Indigenous People IP/ Indigenous Cultural Communities ICCs. The IPs should be provided equal access to education, through the educational system public or private entities. Thus providing education in their own languages. DepEd Order No.62, line no.5 states that the Department of Education gives primary importance to the principle of participation, inclusion, and empowerment among others. Relative to the aforementioned provisions, the IP schools in Abra have but very minimal available resource materials being use in the classrooms. Added to this, there is a need to complete the four (4) minima as requisites for the use of the languages. (Orthography, Primer, Grammar Guide, Dictionaries and literatures).

The absence of written short stories and other literary genres in the IP schools necessitates the conduct of a Division Orientation -Workshop on Writing, Contextualizing Short Stories, and other Literary Genres, to be held on September 11-13, 2019, at West Loch Park Hotel, Sto. Domingo, Ilocos Sur.

- 2. The objectives of the activity are;
  - To equip the participants with the necessary knowledge in the production of instructional materials.
  - To hone the skills of the participants in writing
  - Submit initial outputs on short stories, and other literary works.
