**REQUEST FOR THE SUBMISSION OF SCHOOL-BASED FEEDING PROGRAM (SBFP) TERMINAL REPORT (PTR) SCHOOL YEAR 2019-2020**

1. Pursuant to the Deped Order No. 023 s. 2020 on Supplemental Guidelines on Implementation of SBFP SY 2021-2020, the Department of Education through the Bureau of Learners Support Services-School Health Division (BLSS-SHD), the Schools Division of Abra through the School Governance Operation Division (SGOD) - School Health Section (SHS) continues to implement the said program in accordance with General Appropriations Act (GAA) for FY 2020 and in compliance with Republic Act No. 11037 "Masustansyang Pagkain para sa Batang Pilipino Act".
2. The program primarily aims to help improve the nutritional status of the beneficiaries at the end of the School-Based Feeding Program (SBFP)-Nutritious Food Products through food packs distribution for 60 feeding days. Secondly, it aims to improve the learner's health and nutritional values and behaviour.
3. Anent to this, the Department of Education-Schools Division of Abra started the daily feeding last October 12, 2020 and must be completed on December 10, 2020. All SBFP schools must submit the Program Terminal Report (PTR) using SBFP Form 5 on or before December 28, 2020 to the respective School Nurses in their areas of responsibility for district consolidation.
4. All district consolidated SBFP Program Terminal Report (PTR) using the SBFP Form 5 must be submitted at the Schools Division Office-SGOD, School Health Section on or before January 04, 2021
