

CONTINUOUS QUALITY ASSURANCE, DOWNLOADING AND MONITORING ON THE UTILIZATION OF THE THIRD QUARTER SELF-LEARNING MODULES/ SELF -LEARNING WORKSHEETS SILNAG VIDEO LESSONS

1. The Department of Education requires the compliance to DepEd Order #12 Series of 2020 (Adoption of the Basic Education Continuity Plan for School Year 2020-2021 in light of the COVID-19 Public Health Emergency), particularly provision of access to appropriate, quality learning resources, the Schools Division Office, CID initiated the development, rigid continuous quality assurance (CQA) and harvesting of modified contextualized K- 3 Worksheets /Self-Learning Modules for the third quarter from January to March 07,2021.
2. Cognizant to this, the Office reiterates that only materials which were subjected to rigid quality assurance in terms of copyright standards, SOCIAL CONTENT GUIDELINES, and quality instructional content evaluation being conducted by the Central Office-BLR, Regional LRMD and Division LRMS will be reproduced and used by the K-12 learners.
3. Teachers and school heads are instructed to download the quarter 3 central office and regional office developed grades 4- 12 materials from <https://tinyurl.com/CARmodules> . While the Division developed K-3 materials will be downloaded from <https://tinyurl.com/Q3AbraKto3SLM>.
4. Status of reproduction /printing by the schools will be monitored weekly and will be reported to the regional LRMS help desk every Thursday.
5. Learning Area Supervisors shall monitor the utilization of the SLMs, Worksheets and video lessons and submit reports as to issues, concerns, and gaps relative to the materials' accuracy and effectiveness.
6. Should there be errors in the content, illustrations, social contents, and MELC alignment of the materials, teachers and school heads are responsible **NOT to UPLOAD** to social media rather they are obliged to submit such concerns to SDO Abra ERROR WATCH via <http://lrmsabra.blogspot.com> for appropriate action.
