

DIVISION VIRTUAL TRAINING ON DEVELOPMENTALLY APPROPRIATE PRACTICES IN EARLY LANGUAGE, LITERACY AND NUMERACY PROGRAM

- In pursuit to excellence and with the thrust of ensuring the continuity of learning in basic education amidst the COVID-19 pandemic, the Schools Division of Abra through the Curriculum Implementation Division will conduct a Division Virtual Training on Developmentally Appropriate Practices on Early Language, Literacy and Numeracy Program on May 12-14, 2021 at the Third Floor Conference Hall, SDO-Abra.
- 2. The Writeshop aims to:
 - a. enhance pedagogical knowledge, skills, and attitudes on early language and literacy;
 - b. improve ability to assess learners' language and literacy skills; and
 - c. sustain commitment in providing worthy teaching experiences to improve instruction and learning outcomes.
- 3. The participants of this writeshop are the identified teachers who serve as Learners' Support Aides with the assistance of the Public Schools District Supervisors. The resource speakers are Nenita P. Sabino of Agtangao Elementary School, Fernandina B. Lagundino of Bangbangar Elementary School, Pilita C. Apolinar of Suyo Pilot Elementary School and Esteban Lope N. Tamayo of Toon Elementary School.
- 4. Public Schools District Supervisors are requested to make necessary arrangements as to the possibility of using one laptop connected with a Daylight Projector and speaker for the participants to utilize in each of the Municipal Districts. The link of the said virtual training will be informed to the participants once finalized.
- 5. Lunch and two snacks for the whole duration of the training of the Technical Working Group, Resource Speakers and Public Schools District Supervisors shall be charged against ELLN Funds while travelling expenses shall be charged to local funds/school MOOE or any other sources of funds subject to the usual COA accounting and auditing rules and regulations.
- 6. Immediate dissemination of and compliance with this Memorandum is directed.
