

1. Relative to RM 203 s. 2021 re: Implementation of DepED Order No.017 s. 2021, **Extending the Deadline for Submission of Supporting Documents for Provisional Compliance Certificate**, all SDOs are directed to closely monitor and provide necessary technical assistance to private schools to ensure compliance to guidelines. Furthermore, special attention is invited to item no.4 of the said issuance extending the deadline for submission of the minimum documentary requirements from December 29, 2020 to June 15, 2021 and item setting the effectivity of the order to January 1, 2021.
2. To provide further guidance, Quality Assurance Division (QAD) will conduct an online Validation of all 2020-2021 Learning Continuity Plans (LCP) submitted by private schools on June 16, 2021 to July 30, 2021 and link will be sent on June 14, 2021. Prior to this activity, SEPS-SMME shall have a virtual orientation with the QAD personnel on June 10, 2021 at 10AM. Enclosed is the schedule of virtual orientation.
