INVITATION TO BID FOR

Supply and Delivery of Food Commodities for the Implementation of School Based Feeding Program (SBFP)- Nutritious Food Products (NFP) SY 2021-2022

1. The Department of Education-Schools Division Office of Abra (DepEd-SDO Abra), through the General Appropriations Act (GAA) intends to apply for the Supply and Delivery of Nutritious Food Products with an Approved Budget for the Contract (ABC) amounting to Five Million Five Hundred Six Thousand Seven Hundred Four Pesos and Zero Centavos (Php 5,506,704)

The Nutritious Food Products being required are as follows:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DepEd-SDO Abra now invites bids for the above mentioned project.

Delivery of the Goods is required within 60 calendar days upon the effectivity of the Notice to Proceed.

Bidders should have completed, within at least 6 months from the date of submission and receipt of bids, a contract similar to the Project. Bidders shall be certified by the DOST as FNRI (Food and Nutrition Research Institute) Adaptor. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from Department of Education-Schools Division Office of Abra, Zone 3, Bangued, Abra and inspect the Bidding Documents at the address given below during Mondays to Fridays, 8:00 am to 5:00 pm except during holidays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 19, 2021, from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos Only (Php 10,000)

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in any of the following: presented in person or through electronic mails.

- 6. The DepEd-SDO Abra will hold a Pre-Bid Conference on October 25, 2021, 2 o'clock in the afternoon at DepEd SDO Abra Conference Hall, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual/personal submission at the office address indicated below on or before November 8, 2021, 2 o'clock in the afternoon. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in an amount not less than the required percentage of the ABC.
- 9. Bid opening shall be on November 8, 2021, 2 o'clock in the afternoon at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The DepED-SDO Abra reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
