1. To enhance the enhance implementation of the Basic Education-Learning Continuity Plan (BE-LCP) of the Department of Education (DepEd) and in reference to the Libro Ni Abrenio CQA of the LRMS, the Curriculum Implementation Division- LRMS will conduct the Division-google-based CQA of LR from March 17-31, 2022 through self-paced modality by the identified Evaluators.
