**REITERATION OF IMPLEMENTATION OF MODULAR DISTANCE LEARNING  
AS PROVIDED IN DEPED ORDER 37, s. 2022**

1. In consideration of the well-being of the learners affected by extreme climate conditions as they attend in-person classes, this Office reiterates DepEd Order No. 037, s. 2022, titled "Guidelines on the Cancellation or Suspension of Classes and Work in Schools in the Event of Natural Disasters, Power Outages/Power Interruptions, and Other Calamities" and OASOPS Memorandum No. 2023-077.
2. With the beginning of the warm and dry season in which high heat index forecast is expected, this Office reminds School Heads of their authority and responsibility, consistent with Rule VI, Section 6.1 of DepEd Order No. 01, s. 2003 or the Implementing Rules and Regulations of Republic Act No. 9155, to suspend in-person classes and implement alternative learning delivery mode in cases of unfavorable weather and environment such as, but not limited to, extremely high temperatures which may considerably affect the conduct of classroom learning and put the learners' health and wellbeing at risk.
3. School Heads shall submit request for the conduct of face-to-face classes from 7:00 a.m. to 10:00 a.m. and alternative delivery mode (ADM) in the afternoon from the Office of the Schools Division Superintendent for monitoring purposes.
4. School Heads are mandated to inform stakeholders/parents/guardians about this matter and to remind them of their responsibility to ensure safety of their children during the administration of the ADM.

5. **For monitoring and evaluation**, the Disaster Risk Reduction and Management Services (DRRMS) shall continue leading the implementation of existing mechanisms for monitoring, reporting and responding to the impacts of such phenomenon on DepEd schools and the activation of DRRM teams.

The School Health Unit shall monitor the implementation of precautionary measures, safety and health protocols during this time of extreme temperatures.

The Curriculum Implementation Division (CID) shall lead the monitoring, reporting and responding to the needed adjustments to learning delivery strategies.

6. Teachers should stay in the classroom during the implementation of the ADM to prepare the necessary learning materials needed in the implementation.
7. This shall take effect immediately and will remain in place until further updates are provided.
8. Immediate and widest dissemination of this memorandum is directed.
