**DIVISION TRAINING OF TRAINERS (DTOT) ON HIGHER ORDER THINKING  
 SKILLS – PROFESSIONAL LEARNING PACKAGES (HOTS-PLP)  
 FOR ENGLISH TEACHERS (BATCH II)**

To: Public Schools District Supervisors  
 Secondary School Principals

1. Corollary to DepEd Memorandum dated May 26, 2023 titled Conduct of the National Training of Trainers for Higher Order Thinking Skills-Professional Learning Packages (HOTS-PLP) for Science, Mathematics and English signed by Glona Jumamil-Mercado, Undersecretary for Human Resource and Organizational Development (HROD), the Curriculum Implementation Division (CID) will be conducting a Division Training of Trainers on HOTS-PLPs in English on May 13-17, 2024 at a venue soon to be announced.
2. The activity aims to:
  - support the teachers in understanding HOTS and in reflecting these skills in their respective classroom practices through the development of HOTS items/questions for English.
  - help teachers performing pedagogy and assessment practices that promote Higher Order Thinking Skills (HOTS).
  - develop guide materials intended for master teachers, school heads, and supervisors to support them in their mentoring roles in schools with a focus on helping teachers and
  - provide the participants with opportunities to apply their skills in using the SOLO taxonomy.
3. Participants and program management team are advised to check in on May 13, 2024 at 2:00 PM onwards and are to check out after the training on May 17, 2024. The first meal is dinner on May 13, 2024 and the last meal PM snacks on May 17, 2024. Participants are requested to coordinate with the training team for any dietary concerns.
4. The cost of board and lodging of all participant shall be charged against the Division HRTD Funds while the travel and other incidental expenses of the participants shall be charged against local funds/school MOOE and other sources of funds subject to the usual COA accounting and auditing rules and regulations.
5. Immediate dissemination of and compliance with this Memorandum is desired.
