

Guidelines in the Administration of the 2024 Regional Achievement Test

The guidelines in the administration of the 2024 Regional Achievement Test (RAT) will adapt the provision as stipulated in the Regional Memorandum No. 146, s. 2020 with the following revision and additional guidelines

1. Test Takers

The RAT shall be administered to cordillera learners in Grade 6 and 10 in all regular and science programs in public schools and ALS elementary and junior high school completers.

Mode of Administration and target Schools/Learning Centers

The RAT is an online school-base test. Thus, all public elementary and secondary schools and community learning centers (CLCs) equipped with computer units with stable internet connection are the target schools and CLCs but it is encouraged that even those without internet may be included, the schools without connection will make arrangement with the near by schools with internet connection.

3. Schedule of Administration

For the administration of the 2024 RAT, it shall be done per schedule such that all schools with internet will be scheduled on the first day while the 2nd and other days will be the schools without internet connect, wherein the testing center are the nearby schools with internet connection.

4. Number of Examinees per Testing Room

The number of examinees per testing room will be dependent on the availability of computer units per testing room. Examinees per grade/category shall be alphabetically arranged in the whole grade level regardless of gender.

- 5. Testing Procedure
 - a. Before the start of the test
 - The Schools Division Office (SDO) through the DTC shall submit to the regional office the list of participating schools/centers through the RAT focal person. Please see Annex A for the template for the list of participants.
 - ii The regional RAT focal person shall send the link to the DTC and ALS coordinators.
 - iii The DTC and ALS focal shall be in-charge in sending the link to all the school testing coordinator (STC) or the school heads.
 - iv On the day of the test the STC or the School ICT shall send the link of the RAT send by the DTC and send it to the DepEd email of the examinees in each of the computer units.
 - Note: The examinees shall be the one to open with the assistance of the STC and the School ICT and inform the examines to start with information the 5-learning area.



- b. During the test proper
 - i. The STC orient the examinees in opening and closing of the test links.
 - ii The STC ensure that each examinee is able to submit his or her answer before closing the test link.
 - iii The STC and School ICT supervises the conduct of the test.
- c. After the test
 - i The STC, DTC shall accomplish the online monitoring and evaluation report
 - ii RAT focal removes access to the test links.
