**STRENGTHENING ALTERNATIVE LEARNING SYSTEM MAPPING ACTIVITY AT
SDO ABRA S.Y. 2024-2025 AND REITERATION OF DEPED ORDER NO. 3,
Series 2024 "TEACHERS VACATION"**

1. The Department of Education (DepEd), through the Curriculum Implementation Division Alternative Learning System Section (CID-ALS), will announce the conduct of Alternative Learning System (ALS) intensified mapping activity for school year (SY) 2024-2025 at Schools Division of Abra on July 1-19, 2024.
2. ALS teachers during the mapping period July 1-19, 2024 are mandated to conduct intensive literacy mapping and considered to do full-time field work that can be done by clustered district as teamwork (separate arrangement will be set by EPSA). ALS SBM School heads are advised that certificate of appearance from community / barangay officials and or school head in the community is enough to support their DTR not requiring them to stay in the office and do the biometrics that may create hassle from doing fieldwork specially in going to the remote areas.
3. Literacy mapping forms district consolidation will serve as an output to be submitted to the EPSA's at the Schools Division Office. Enrolment of qualified quality learners in adherence with admission policies of providing MCR/PSA birth certificates is necessary. Reports are expected to be submitted at the schools division office ALS section on or before July 26,2024.
4. With regards to Deped Order No. 003, s. 2024, the Implementing guidelines on the school calendar and activities for the school year 2024-2025 this office would like to reiterate the following:

- a. Item no. 7, "No voluntary or mandatory tasks or activities shall be assigned to teachers from June 1-30, 2024."
