# SCREENING AND SELECTION OF POTENTIAL LEARNING RESOURCE EVALUATORS (LRES) FOR THE SCHOOL YEAR 2024-2025 ONWARDS

- Compliance to the Regional Memorandum No. 375 s, 2024 dated June 11, 2024 on Screening and Selection of Potential Learning Resource Evaluators (LREs) for the School Year 2024-2025 Onwards, the Curriculum Implementation Division Learning Resources Management Section (CID-LRMS) is currently expanding the list of potential LREs to facilitate the quality assurance of the different learning resources (LRs) used in all schools of the division. The Division Screening and Selection Committee (DSSC) is requested to facilitate the screening and selection of potential LREs.
- The screening of potential LREs must be guided by the DepEd Memorandum no. 217 s, 2016 stating the Guidelines on the Screening, Selection, and Training of Potential Learning Resource Evaluators (LREs).
- It is reiterated that the Potential LREs must meet the following minimum qualifications:
  - a. Bachelor's degree;
  - With at least five (5) years of teaching experience in the learning area being applied as LRE;
  - c. Has at least 24 hours of relevant training on the development and evaluation of LRs; and
  - d. Not an author, editor, or consultant of any commercially-developed LRs submitted to DepEd for procurement in the last three years from the date of application.
- 4. It is likewise reiterated that potential LREs must be physically fit, willing and able to travel, and participate in the series of content evaluation workshops at a accessible venue.

- 5. In addition, pursuant to the rationalization of teacher's workload as stipulated in DepEd Order No. 005 s, 2024, potential LREs must be limited only to public schools district supervisors (PSDSs), principals, head teachers and other non-teaching and teaching related personnel who meet the minimum qualification.
- 6. With reference to BLR Memorandum No. 05-810 s, 2024, Education Program Supervisors as the default division the learning area specialists, shall be included in the database of potential LREs subject to capability building of the BLR. On the other hand, EPS are requested to assist the Division Screening and Selection Committee to ensure that the potential LREs have excellent track record in their respective content areas. EPSs are likewise requested to ensure that all the following learning areas are assigned with at least five (5) potential LREs.
