REITERATION OF THE DIVISION MEMORANDUM NO. 058, s. 2024 DATED FEBRUARY 6, 2024 (UPDATING OF THE CHILD PROTECTION POLICY IN THE DEPED-CAR LEGAL SERVICES INFORMATION SYSTEM (LSIS 3.0) FOR SY 2024-2025)

**To: Assistant Schools Division Superintendent
 Chief, Curriculum and Implementation Division
 Chief, School Governance and Operations Division
 Public Schools District Supervisors
 Public and Private Elementary and Secondary School Heads
 All Others Concerned**

1. The Department of Education-Cordillera Administrative Region (CAR) has formally implemented the adoption of the Legal Services Information System (LSIS) which was designed to monitor the status of the Child Protection Policy of all schools in Elementary and Secondary both in public and private.
2. Therefore, all schools of Elementary and Secondary both from public and private of SDO Abra must adhere to the prescribed utilization of the system for the completion of requisite documentation pertaining to the Child Protection Policy (CPP), as stipulated in DepED Order No. 40, s. 2012. Thus, obliged to undertake the updating of the Child Protection Policy School Profile for the SY 2023-2024. The release of Certification of Compliance should not be issued if not compliant.
3. The updating of the CPP School Profile was due last March 5, 2024. However, as of June 30, 2024 only 213 out of 271 Public Elementary Schools, 44 out of 46 Public Secondary Schools, 3 out of 11 Private Elementary Schools and 18 out of 23 Private Secondary Schools has updated in the system. It is therefore expected of the 100% utilization of the system for this SY 2023-2024 and should be updated until July 12, 2024.
4. Attached is the list of schools who have not updated in the system. (see Enclosure No. 1).
5. For dissemination, guidance and strict compliance of this Memorandum is desired.
